### SAFEGUARDING POLICY PROMOTING A SAFER CHURCH

The following policy was agreed at the Parochial Church Council (PCC) meeting held on 7<sup>th</sup> November 2023.

In accordance with the Church of England Safeguarding Policy our church is committed to:

- Promoting a safer environment and culture. •
- Safely recruiting and supporting all those with any responsibility related to children, young people and • vulnerable adults within the church.
- Responding promptly to every safeguarding concern or allegation. •
- Caring pastorally for victims/survivors of abuse and other affected persons. ٠
- Caring pastorally for those who are the subject of concerns or allegations of abuse and other affected • persons.
- Responding to those that may pose a present risk to others. •

The Parish will:

- Create a safe and caring place for all. •
- Have a named Parish Safeguarding Co-ordinator (PSC) to work with the incumbent and the PCC to • implement policy and procedures.
- Safely recruit, train and support all those with any responsibility for children, young people and adults to • have the confidence and skills to recognise and respond to abuse.
- Ensure that there is appropriate insurance cover for all activities involving children and adults undertaken • in the name of the parish.
- Display in church premises and on the Parish website the details of who to contact if there are • safeguarding concerns or support needs.
- Listen to and take seriously all those who disclose abuse. .
- Take steps to protect children and adults when a safeguarding concern of any kind arises, following • House of Bishops guidance, including notifying the Bishop's Safeguarding Adviser (BSA) and statutory agencies immediately as per the flowchart in Appendix A
- Offer support to victims/survivors of abuse regardless of the type of abuse, when or where it occurred. ٠
- Care for and monitor any member of the church community who may pose a risk to children and adults • whilst maintaining appropriate confidentiality and the safety of all parties.
- Ensure that health and safety policy, procedures and risk assessments are in place and that these are • reviewed annually.
- Review the implementation of the Safeguarding Policy, Procedures and Practices at least annually. •

Each person who works within this church community will agree to abide by this policy and the guidelines established by this church.


